JUDGMENT

SYED MAHMUD HOSSAIN, J: Mr. Abdur Rahim, learned

Advocate, appearing on behalf of the leave-petitioner,

submits that he does not challenge the propriety of the

impugned judgment but an explanation is necessary as to rate of payment of interest on the FDR deposited by respondent No.1. He further submits that the High Court Division directed to pay interest at প্রচলিত হারে (prevailing rate) and that a confusion has arisen what should be the প্রচলিত হার.

Dr. Rafiqur Rahman, learned Senior Advocate, appearing on behalf of respondent No.1, on the other hand, submits that he does not have any objection if this Division gives an explanation as to the rate of interest at প্রচলিত হারে .

Having considered the judgment, we find that the High Court Division found that claiming interest at the rate of interest on C.C. (Cash Credit) loan over the special fund was not maintainable. Though the High Court Division found that respondent No.1 is not entitled to interest on the rate to be calculated on C.C. loan, it, however, stated that the rate of interest would be at প্রচলিত

হারে . Now the confusion arises what would ^{be meant} mean by "প্রচলিত হার".

Having considered the submissions of the learned Advocates of both the sides, we are of the view that প্রচলিত হারে would mean in the instant case the interest to be calculated on long term FDR. The leave-petitioner is, therefore, directed to pay interest on the FDR as per on the rate of interest applicable to long term FDR within 1
